



## Let's cover legal necessities!

### Legal Requirements for Wedding Officiants Checklist

As a wedding officiant, it's essential to understand the legal requirements associated with performing marriages in your region. Use this checklist to ensure you're compliant with all necessary regulations:

#### 1. Research Jurisdictional Laws

- Identify the legal requirements for officiating weddings in your specific city, state, province, or country.
- Contact your county/parish and ask what is required for wedding officiants to both:
  - Operate a business
  - Legally marry a couple and sign the required license/certificate
- Document the specific regulations or restrictions that apply to wedding officiants in your area and create a checklist to follow.

#### 2. Obtain Necessary Credentials

- Determine if you need to be ordained, registered, or both to officiate weddings legally.
- If ordained, ensure that your ordination is recognized and valid for performing marriages in your jurisdiction. (*ULC licenses have been named specifically in several court cases as NOT a legitimate ordination or real religious organization.*)

**3. Apply for Officiant License or Registration**

- If required, complete the application process for obtaining an officiant license or registration after you've successfully completed your ordination as required by the state/local government.
- Provide any necessary documentation, such as proof of ordination or religious affiliation.



**Tip:** It is a good idea to order a physical certification/license (proof of ordination) when you become ordained, even though it is usually not required.

**4. Understand Marriage License Procedures**

- Familiarize yourself with the process for couples to obtain a marriage license in your area. Your state will have requirement information available online or by speaking to an employee.
- Understand any waiting periods, documentation requirements, or fees associated with obtaining a marriage license.
- Write down all requirements and the process for your couples to see. List on your website and/or create a document for them to download/print.

**5. Verify Identification and Legal Documents**

- Confirm that you are performing marriages for legally eligible couples.
- Verify the identification and legal documents of the couple, including proof of age and any required paperwork.

**6. Complete Marriage Certificates and Documentation**

- Understand the process for completing and filing marriage certificates and other necessary documentation. Be sure to know all important dates such as:
  - How long the license is valid before having a ceremony, signing, and turning it in
  - When the license must be turned in after the wedding ceremony
  - Other important time frames)
- Ensure accuracy and completeness when filling out marriage certificates to avoid delays or legal issues.

## 7. Stay Informed About Updates and Changes

- Regularly check for updates to marriage laws and regulations in your jurisdiction.
- Stay informed about any changes that may affect your status as a wedding officiant or the requirements for performing marriages.

## 8. Maintain Records and Documentation

- Keep detailed records of the weddings you officiate, including dates, locations, and couples' information.
- Store copies of marriage certificates and other relevant documents in a secure and organized manner.

## 9. Renew Licenses and Registrations

- Be aware of any expiration dates or renewal requirements for officiant licenses or registrations.
- Ensure that you renew your credentials on time to maintain your legal authority to officiate weddings.

## 10. Seek Legal Advice When Necessary

- Have a legal professional review any binding contracts before implementing them into your business.
